

from the US has also joined the Board, so you have a very strong and hardworking team heading up the Society.


Debra has been keeping your Board hard at work during the Covid lockdown and we have accomplished a lot.

Clan Baird Gathering in Scotland is July 30th to August 9th, 2021Clan Baird Society Worldwide is providing a Scotland Tour for those who want to take a bus tour as part of our Clan Baird Gathering in 2021. We are currently getting the tour set up, but we estimate it will cost about \$800.00 per person for the bus/van transportation and tickets for the events each day. The tour will only cover ground transportation in Scotland,



Everyone will be setting up their own hotels/houses/cottages/B&B accommodations in Aboyne, Scotland (please try to stay within walking distance of the city center). There are several links on the Clan Baird Society Worldwide website, https://www.clanbairdsociety.com/blank under the "Scotland 2021" menu button on the main bar at the top.

People will have to pay for their own meals/food during the trip.

People will need to set up their own flights to Aberdeen, which is about an hour and a half from Aboyne. You should arrive early on July 30, or before, if you wish to spend a day or so in Aberdeen, before the tour bus/van picks you up.

We are planning to use vans so that we can easily travel to Pennan, New Aberdour, and places many of you have not yet been. The roads are smaller up there, and we want all to be able to see everything without a great deal of walking.

We will begin accepting reservations in October and will close sign-up for the tour by January 30th, 2021.

The membership overwhelmingly accepted those new By-Laws, with only three negative votes in the entire group. The Board appreciated this serious vote of confidence from the membership and will work hard to live up to your confidence in us. I welcome our Commander, Richard Holman-Baird as the President of the Society, Penny Carpenter, Ross Baird, John Baird, Branton Baird, as members at large, and Heather Snyder as our Publicist. I will serve as Convenor and Chair of the Board.

> has Another initiative emerged from all that work. It is that we want to be more active in other countries, and truly be worldwide; not so centered in the US. In planning for our 50th anniversary in 2022, it seems to the Board that consolidating our efforts to set up affiliates in other countries is in order, as well as increasing expansion of all activities in those countries. We do not believe these are mutually exclusive,

and in fact, we believe they are mutually inclusive, helping grow our family ties, while making sure individual needs are met for each country.

Plans for the 2021 Gathering in Aboyne, Scotland are under way and we are still working on prices for tickets for each



The Grandfather Cairn and the Bairds, as well as a new Cairn in Scotland


In looking through old Gryphons sent us by Mrs. Virginia "Ginny" Baird (wife of our past Society Piper, Kenneth Baird), we found this article about the cairn at Grandfather Mountain. As many of you know, the Society was organized by Frances and Byron Owsley Baird and

the Viscount Stonehaven, Sir James Ian Baird, who later became the Earl of Kintore. With a small group of loyal and influential followers, at Grandfather Mountain Highland Games in 1972, the Society was born.

For the 25th Anniversary of Grandfather Mountain Games in 1980, a stone procured from Auchmedden Estate by Lord James Ian Baird Keith, Earl of Kintore, and brought to

the US by Byron and Frances after their visit to Scotland, was placed in the Cairn, in Panel One, Number One stone. The Winter 1981 Gryphon reported the stone to be one of the most beautiful in the Cairn. The next time you are at Grandfather, be sure to find our stone and remember all those who have gone before. We stand on the shoulders of giants, who had vision, and knew we would need this Society in 2020, and our memories of better times.

In Summer 2019, we gathered on the Auchmedden Estate once again, at the Mill of Nethermill, owned now by Bill and Lynn Pitt, Society members. They invited the Bairds to place a plaque commemorating the rock bridge that still stands on their property. It was built in 1719 by the Bairds and the Gardens, linking Banffshire and Aberdeenshire for the first time by wagon road. 2019 was the 300th anniversary, and our Commander, Richard Holman Baird,



with Isaac Baird speaking Gaelic to the crowd, dedicated the plaque given by the Society.

It is now set in its own cairn, built by Bill and Lynn, and all can see it the next time they visit. I hope you attend the 2021 Grandfather Games, where we will have Richard's Installation Ceremony.

DEDICATION

The Baird Family Society was proud to be

a Clan participating in the dedication of the Cairn to the founders of the Grandfather Mountain Highland Games on the Game's 25th Anniversary last summer. Robert Baird of Oradell, N.J. was our tartan bearer fo the Service. The Cairn was beautifully constructed of North Carolina native stone by Douglas James Ferguson, local artist and designer. The stones donated by each Clan from their Scottish Clan lands having been cut and polished, filled three panels around the Cairn with a fourth yet to be filled. Ours from Auchmedden was stone number one in panel number one and was among the most beautiful. A bronze plaque in front recorded the name of each clan donating a stone and gave the location of each in the panels.

"What is a cairn?" you might ask. "Cairn" is a Gaelic word that means a "heap of stones". It is used to mark a grave or a historical spot but is always a memorial In medieval Scotland, it was the practice when passing a burial place of a loved one to place a stone on the grave and ask a prayer for the repose of the soul. Chief Baird

We live in exciting times. In August 2019 Richard Holman-Baird was commissioned by the Lord Lyon as Commander of Clan Baird, making him the first to lead the Clan in over two hundred years. In addition, the Lord Lyon is currently considering the evidence presented by Sir James Baird Bt of Saughtonhall in support of his claim to be Chief of Clan Baird.

It's ironic that The Baird Letters - a series of letters written between brothers Gilbert Baird and Andrew Baird in the seventeenth century and now preserved in University archives - are cited by Dr Davis of Buckingham University as documentary evidence of the existence of a robust clan system and the powers and responsibilities of a Chief at the time, and yet the clan they're discussing now doesn't have a Chief.

Chiefship is not just rooted in the past. In the last two years the Clan Carruthers and the Clan Buchanan have both been elevated by the affirmation of Chiefs by the Lord Lyon. In both cases, the research to prove who is the prime claimant took between 10 and 20 years, and

then up to two more years of scrutiny and analysis by the Lord Lyon, before he was fully satisfied and prepared to admit the chiefships. After the Lord Lyon endorsed the Carruthers Chief, the Convenor of the Clan Carruthers Society said: "We can now take our rightful place alongside other Scottish clans with legally accepted Chiefs" Also he has words for other Clans as he hopes it will; "encourage other armigerous clans to persevere in seeking to identify and confirm their Chief..."

The Court of the Lord Lyon is the authority for heraldry in Scotland and the Lord Lyon who heads it was originally responsible for verifying the genealogy of the King of Scotland. The Court has the responsibility for maintaining the Public Register of Arms in Scotland and for prosecuting any unauthorised use of Arms. Arms, or Coats of Arms, belong to one person or institution at a time and can be inherited by the most direct living descendent.

In Scotland, "Chief" is not just a title of honour bestowed on a person by the Sovereign, through the Lord Lyon. It confers to the entire family a "noble corporation". There are currently only about 160 clans that have Chiefs recognised by the Lord Lyon (and over 200 without).

For a Scottish clan or family that is currently chiefless - as with Baird - the search for the rightful genealogical Chief starts by searching for the first coat of arms registered by that family in the Public Register of Arms in Scotland. These Arms are termed the "undifferenced arms" of the family and is considered the chiefly line. The person who can genealogically prove he or she is the most direct living descendant of the chiefly Arms has the best opportunity to petition the court for a request to matriculate the Arms, and to request to be named the Chief of the Name and Arms of Baird.

For our clan of Baird, the first Coat of Arms registered with the Court of the

Lord Lyon was in 1672 for Sir James Baird, 5th of Auchmedden. Today, any potential Chief needs to prove a direct genealogical link back to him. The proof requires the birth, marriage and death certificates of all direct descendants or other official documents such as legal contracts.

Richard Holman-Baird's position as Commander of Clan Baird means the clan does at last have a leader. However, the Lord Lyon made it clear that the position of Commander is an interim role for a period of 5 years and is specifically designed to focus the clan on finding the genealogical heir who can be the true Chief. A clan with a Commander is less honourable than a clan with a Chief so the clan's ultimate aim must be to find and support a potential Chief's petition to the Lord Lyon. While a Commander is a leader of the clan for now, a Chief links current day clanspeople back to the deeds and glories of the past, and elevates the status of the clan itself into the future.

As announced by the Clan Baird Society earlier this year, there is now a strong contender to be Chief of Clan Baird - After 20 years of detailed research, Sir James Baird Bt of Saughtonhall has approached the Lyon Court and submitted a petition to prove a direct link to the 1672 Arms. If granted, he would become Chief of Clan Baird.

I would very much like us as a clan to support this, as it is an incredibly exciting step in the Clan Baird history, but we need to show a little patience as the petition is under legal review by the Lord Lyon and no one is allowed to exert undue influence over the Lyon's decisions - for fear of contempt of court.

The Court of the Lord Lyon is a court of law within the Scottish judicial system. If another petitioner claims a stronger line back to the 1672 Auchmedden Arms the

case may be held in public, however the time allowed for opposing petitions has ended. In this case, as there is no opposing petitioner, it is likely the assessment will be held behind closed doors and the result announced in due course.

Understandably, in this COVID-19 affected year, the scrutiny process will be slower than in more normal times, but it could be that 2021 will see another great leap forward for our Clan Baird status!

(technically) Armigerous means 'bearing a coat of Arms'. Note that a clan itself is not a legal entity, so cannot bear arms. Clan societies, clanspeople and chiefs etc can bear arms



Perserving St. Drostan's: The origin of Christianity in Mainlaind Scotland and The Bairds

library of John More, the Bishop of Ely, and presented its contents to the Cambridge University library. A single shaw. The book set the Gaelic world aflame. Despite appearing to be a new testament manuscript, several additional pages kept secrets for over 800 years and changed history. Upon translation a few year later, the book was given a new name, The Book of Deer.

The exact provenance of how the Book of Deer came into English hands is not entirely clear. Historians hypothesize that invading English armies looted the book in either the 13th or 14th centuries. An illuminated copy of the New Testament, the book remained relatively safe and in good condition until its discovery, tucked away in various libraries, guarding its ancient secrets in the marginalia.

The marginalia of the book provided a narrative in the form a legends and land grants that transforms Buchan (North east Aberdeenshire) landscape and myth. The writings described how Colum Cille(English: St. Columba), the same saint that founded the magnificent Abbey on Iona, came east with Drostán MacCosgrach (English: St Drostan, Son of Cosgrach), his foster son or disciple(dalta) in 560 AD. The companions arrived at the seat of Bede Cruithnech (English: Bede the Pict) in Aberdour. Bede, holding the ancient title of Mormaer, gave land to Drostán in perpetuity



Drostán was affecting, denied their request. Despair must have set in for the two companions. Then, the hand of Providence played its part when suddenly the Mormaer's son and heir fell deathly ill. We aren't told if the Mormaer called his druids, healers, or holy people, but we can surmise this was implied in the legend as later the Mormaer begged for aid from the missionaries. The Mormaer arrived and asked the missionaries to anoint and pray for his dying son. He begged them to heal him his son's sickness. The saints anointed and prayed for the Mormaer's son. Astonishingly, the son recovered where other methods failed. Upon his miraculous

recovery, the Mormaer's heart softened and the once fiery Pictish leader now offered land for a monastery. Together, the marginalia states, the two missionary companions founded their monastery. When Colum Cille announced his return to Iona, St. Drostan cried out in sorrow and named the site "Deur" (English: A tear). This was anglicized in to the modern "Deer" and is known as Deer Abbey to this day.

Whether this legend is accurate, or a creation of a later date, is irrelevant

next to the fact that it was written in Gaelic. There in Deer Abbey, in an area that has been historically claimed to be a part of the Scots language heartland, the first written Scottish Gaelic emerged. Further lands grants in the Book, written in Gaelic, show that the language had a strong role in the region. In addition, the book may give insights into the purpose and origins of Pictieh stone carvings as land was granted from Cloch in Tiprat to Cloch Pettite Mac Garnait ("the stone of the well to the stone of sons of Gartnait").

St. Drostan remains firm in his role

St. Drostan remains firm in his role in spreading Christianity. His name, Drostan, does not appear to be a Gaelic name. The name is well attested on Pic-

tish stones, and in welsh legends as Drystan or Tristan. This gives us some clues that St. Drostan may have been a native Pict, or at the very least, a fluent Pictish speaker. The Pictish language skill, linguistically similar to Welsh or Cumbrian, would have been critical in spreading Christianity throughout the country. We find legends of St. Drostan throughout the country. These legends tell that after a long successful career, the saint moved to Glen Esk as hermit. In Glen Esk, the saint is credited with healing the blind. Finally, upon the end of his life, his remains and relics were transferred to a stone tomb in the Church which started his missionary career in

Aberdour. Local legends offer clues to where the relics remain, but in likelihood the relics were destroyed, much like other Scottish relics, during the Reformation.

Time trudged on. The original church built by St Drostan was rebuilt in successive waves. In many cases, the original stones were salvaged and reused in each progressive architectural design. For the Bairds, this Church is special. The site underwent transformation from an Iron Age church, to Anglo-Norman

style Catholic church, and then into the reformed kirk in that late 1500's. When the reformation swept over the land, the Bairds, as local lairds, were offered a chance to transform the Chancel into a memorial Aisle. Despite appearing to be Catholic, the Bairds constructed monuments into the walls and confirmed their genealogy and status in the region. The money used to effect these changes also enabled new construction to occur to bring the building into reformed usage. However, evidence remains of the pre-reformation construction including the Chancel Arch and transepts. In 1818, when the new Kirk in New Aberdour was completed, the site turned into a Graveyard and the stone walls have begun to crumble, including the Baird Monuments.

The Baird Foundation, the successor to the Baird Archaeological and Historical Initiative, was created in part to help preserve Scottish history. Recently, the Foundation has begun the task of initiating preservation of the site with an end

OVERVIEW HISTORY & STATUS OF CBSW

Clan Baird Society Worldwide, Inc. (originally Baird Family Society), is a non-profit, worldwide organization, which began to be formed in the late 1960's and was finally established, with the blessing of the Honourable Lord Lyon King of Arms, in 1972 by Frances and Byron Baird of Florida and our Commander's grandfather, James lan Baird of Ury and Lochwood, 2nd Viscount Stonehaven and later 12th Earl of Kintore and Chief of Clan Keith.

The Earl of Kintore and his children have continued to support the Society through the years, as they still do, including the Newbyth line, today represented by Andrew Baird, when it became active with the Society a few years later. With the recent memberships of Roderick Baird (Saughtonhall) and Douglas Baird (Elie and Durris), these branches of the family have also become active.

Our Mission - "Clan Baird Society Worldwide, Inc. is an organization of Clan Baird Members, formed exclusively for charitable, religious, educational, and scientific purposes; who desire to support the family as a whole and to promote all things Baird, in Scotland and around the world. It is our mission to bring the diasporic Clan Baird together as a unified family; protect all things Scottish, as well as encourage others to do the same; encourage cultural, artistic and historic preservation endeavors; acquire, preserve, restore and act as custodian for Scottish historical records, relics, heirlooms and other chattel in general and those of Clan Baird in particular; educate others about Scottish life; encourage all family Members to discover their heritage; help Members in need; and promote fellowship whenever we gather with family. Membership is open to any individual who claims heritage with the Baird family or with whom they feel a close and devoted relationship."

The current incarnation of the Society became effective on December 2, 2010, when the Articles of Incorporation were filed with the Michigan Department of Energy, Labor & Economic Growth, Bureau of Commercial Services.

The Society was granted Internal Revenue Code 501(c)7 status on November 13, 2013, although the effective date of the tax exemption is given as December 2, 2010, the same as the Articles of Incorporation.

The Gryphon is published 4 times a year. In addition to this website, we maintain a Facebook page and a Blog and there is a separate Society Facebook page in Australia. This website is currently undergoing a major upgrade, so please be patient.

A financial report is published quarterly in the Gryphon. However, details of our records and accounts are confidential.

General meetings are held annually in the summer. Beginning in 2017 with a trip to Scotland, they now alternate between the US during even-numbered years and Scotland during odd-numbered years. Our 2021 Annual Meeting will be held during the Society gathering, which will take place August 6th through the 8th in Aboyne, Scot-

land. We hope that many of you will be able to join us.

Since 2004, the Society has partnered with the Family Tree DNA Baird Project. We encourage all Bairds to participate.

The Society awards an annual scholarship to a student investigating subjects including Scottish history, lore, music, culture, geography, genealogy or some similar topic. Applicants may be an adult and need not be attending a college or university or a member of, or related to a member of the Society.

The Baird Archaeological and Historical Initiative involves the preservation of Clan lands, Heritage sites, Antiquities, and Monuments with the goal to develop, document, and advocate for the preservation of Baird history.

The Society represents Bairds by sponsoring tents at various Highland Games in the US from coast-to-coast and several in Australia. We also host a tent bi-annually during the Society gathering at the Aboyne Highland Games. In the near future we hope to expand into Canada and New Zealand.
